Notice inviting application for Allotment / Distribution of stall at " KARMATIRTHA"

The office Of The Block Development Officer, Bandwan Block ,Purulia has set up 1 (one) no. of marketing complex under the brand name of "KARMATIRTHA" in Purulia District, at- Bandwan, Dist- Purulia under Bandwan Development Block.

Total 35 Nos. of stall to be allotted/ distributed in KARMATIRTHA to the artisans including women artisans, weavers, micro & small entrepreneurs, backward and poor SHG members etc.

Objective of the project: "KARMATIRTHA" is a flagship programme of the State Government. The basic objective of KARMATIRTHA is to provide an ideal ambience for marketing the products of the artisans, weavers, micro & small entrepreneurs, backward and poor SHG members including women artisans and interaction between them and the consumers, buyers, exporters round the year in an organized manner. Thus KARMATIRTHA provides opportunities for organized marketing facilities at the same time there will be wider scope for employment generation through direct and indirect channel.

Each KARMATIRTHA is contemplated in such a way that it will be the centre point of economic activity where trade and commerce will thrive. It also has provision to organize exhibition and cultural events to showcase the regional and cultural heritage. Thus KARMATIRTHA is planned for the overall socio-economic and cultural development of the area where the quality of life of the people will be upgraded.

Terms and Conditions for operation of KARMATIRTHA :

- I) Block level selection Committee on behalf of the District Level selection committee is the sole authority for selection of entrepreneurs / beneficiaries in the User's Group and the decision of the committee is final. Preference will be given to the local micro & small entrepreneurs, artisans including women artisans, backward and poor SHG members, weavers etc. at the time of selection.
- II) The applicant has to be the resident of Bandwan Block
- III) Applications submitted only in prescribed format shall be entertained.
- IV) KARMATIRTHA shall be that exclusive property of Government of West Bengal, through in the custody and use by the entrepreneurs.
- V) The Chairperson of Users' Groups would be a GOWB nominee.
- VI) One 'Special Purpose Vehicle' SPV have already been formed in KARMATIRTHA for the user's group. A nominal up- front members' contribution of Rs. 500/-Will be collected by the SPV. The management of KARMATIRTHA lies upon the SPV and it will function as per Government rules.
- VII) The concerned Department will provide a one-time start -up grand of Rs. 1 lacs to the SPV .
- VIII) Users' Group should have a character of inclusiveness wherein provision for enrolling new prospective entrepreneurs to utilized the facility so that the benefits can for other enlarged.

- IX) The management of the SPV remains with the entrepreneurs of Users' Group. The entrepreneurs of User's Group & selected small and marginal entrepreneurs / artisans of backwards / poor SHGs enmarked for the common Area will utilize the KARMATIRTHA.
- X) The SPV will be empowered to collect user charges / betterment fees from its member entrepreneurs for specific purposes. User charges for services shall be at par with the prevailing market rates.
- XI) The user charges will be kept in a bank account and will be suitably used in conjunction with the start-up money and other realization from the entrepreneurs from time to time.
- XII) The SPV may raise loans from banks to take care of any shortfall, expansion etc. on the condition that the assets in KARMATIRTHA will not be hypothecated/ mortgaged.
- XIII) The SPV shall keep all money not immediately required as reserve found in interest bearing deposits with any scheduled bank in India.
- XIV) Profits SPV will remain with the SPV and distribution of dividends will not be permitted.
- XV) The entrepreneurs shall bear all expenses towards consumption of electricity, water and telephone services and shall be responsible to pay its share of the all the municipal , property or other tax (including service tax)or charges if any , as may be levied in respect of KARMATIRTHA by any statutory authority .
- XVI) All necessary clearances, licenses, regulatory permits and permissions to operate KARMATIRTHA and perform sale of products in KARMATIRTHA shall be in force at all times.
- XVII) KARMATIRTHA shall be operated in accordance with its objectives and shall not be used it for any purpose other than the permitted activities.
- XVIII) Construction of permanent / temporary structure or any alteration, addition or improvement or changed the original condition in KARMATIRTHA , without prior written permission is not permitted .
- XIX) The BDO, Bandwan Block shall not be responsible or liable for any loss for damage in KARMATIRTHA on account of theft of fire or other accident in the KARMATIRTHA.
- XX) The laws of the land to operate KARMATIRTHA, particularly related to labour, tax and environment and regulatory compliances should be strictly adhered.
- XXI) KARMATIRTHA shall be functional six days a week and 10 hours per day minimum or more from 10 am to 9 pm. Unless directed otherwise by local laws as may be applicable.
- XXII) Safety , security and cleanliness / housekeeping of KARMATIRTHA shall be maintained strictly.
- XXIII) Any hazardous activities including storage of explosive / inflammable materials shall not be carried out in KARMATIRTHA.
- XXIV) Waste disposal (in any form) should conform to the state PCB norms.
- XXV) Use of plastic or any material that is in violation of any law is not allowed in KARMATIRTHA.
- XXVI) Open fire arrangement and use of open flame equipment like gas/kerosene store etc. are strictly prohibited except in the area earmarked for the same.
- XXVII) Use of sound system beyond the permissible limit is not allowed.
- XXVIII) Any vendor including food vendor in KARMATIRTHA is not permitted except for the allotted stalls.
- XXIX) Parking of car except for designated parking zone is not permitted in KARMATIRTHA.
- XXX) Displays of the name board in any place other then designated place are not allowed.

The following activities shall be operated at KARMATIRTHA:

- I) Promotion of sale of regional products like handicrafts / handloom, processed food, garments, household goods, agri items amongst others.
 - II) Organize display and sale of any item of tourist interest and public utility.
 - III) Running of stalls / kiosks for selling food items / snacks.
 - IV) Organize exhibition and cultural events to showcase the regional cultural heritage.
- The above list is only illustrative and not exhaustive and may include all activities that are ancillary to the activities listed above. As such, any other activity and product related to the promotion of KARMATIRTHA can be taken up.
