



Sealed tenders are invited to offer hiring charges per month for hiring a newly registered Scorpio (A.C) for the Hon'ble M.O.S., Forest Department.

TERMS & CONDITION

- 1) The vehicle should be newly registered Scorpio (A.C).
- 2) The vehicle must have a Public Carrier Commercial License at the cost and responsibility of the owner.
- 3) The vehicle must be issued against accident at the cost and responsibility of the owner.
- 4) All taxes and relevant charges as per Government Rule must have to be cleared up at the cost and responsibility of the owner in due time.
- 5) The Tenderer will have to submit Xerox with attested copies of all original papers including sale letter , if any.
- 6) The Tenderer will have to bear all cost of repairing and maintainance including remuneration of driver.
- 7) Fuel will be supplied by this office as per relevant government orders as regards consumption of fuel ,that is @ 07 kms. to a litre of diesel and 1 litre of mobil per 500 kms. of run. Money equivalent of short fuel shall not be paid and shall be adjusted by subsequent issue of fuel.
- 8) Tender imposing condition by the Tenderer will not be accepted .
- 9) Tender must have to be signed by the owner and in case of partnership deed , by all the share holders.
- 10) Rate is to be tendered legibly both in figure & words for hire charges per month and/or also per day which should be inclusive of all taxes and incidental charges ,whatsoever may be , but excluding the cost of Fuel (Diesel/Mobil) as per government order. No other fuel, coolant water, break oil etc. will be asmissable.
- 11) The Tender must have to be submitted on or before 29/12/2010 up to 3 P.M in a box placed at C.A section of A.D.M.(G), Purulia and the same will be opened on the same day at 4 P.M. Tenderer may remain present at the time of opening of Tender papers.
