Date of opening of Tender on 14.09.2021 at 02.30 P.M. at the Office Chamber of the undersigned. The Suppliers or their authorized representatives may remain present at the time of such opening.
2. The undersigned reserves the right of accept or reject any or all the Tenders without assigning any reasons whatsoever. The undersigned does not bind himself to accept the lowest quoted rate and shall use discretion to accept rates higher than the lowest to ensure standard quality of the article to be supplied in order to meet the urgent need.
3. The firm(s) whose rate(s) shall be accepted will have to complete the said work with supplying the item within a period of fifteen days/date specified in the supply order failing which his/her order will be treated as cancelled and the undersigned will be liberty to issue supply order to a firm or supplier not offering the lowest rate to meet exigency.

The bidders should submit the copies of following papers duly attested by competent authority:

- a. PAN/TAN (as applicable)
- b. GST valid with up to date return(Certificate of GST to be attached)
- c. Up-to-date Profession Tax Return & Profession Tax Registration Certificate.
- d. Up-to-date Income Tax Return
- e. Trade License up to date.

- f. Credential Certificate for work in similar nature of Rs 100000/-(One Lac only) will be required. The completion Certificate and detailed communicational address of the client must be indicated in the Credential Certificate. Supply Orders will not be considered as Credential Certificate.
- g. For any kind of exemption, on the above mentioned required documents, the bidder shall have to submit authenticated document from competent authority, in support of his claim, at the time of submission of Bid. No claim on a later stage will be entertained. However, the final decision regarding this will be made by the Additional District Magistrate(Gen.), Purulia.
- h. Rate should only be quoted for individual item inclusive of all taxes, delivery charges and installation at DPTRCs and the total rate of all items will be given priority.
- i. All taxes will be deducted as per existing norms.
- j. Materials are to be supplied at the office of the DPTRCs within 7 days from issuing of supply order including cost of unloading.
- k. The payment will be made through RTGS /NEFT after receiving satisfactory supply reports from all concerned. No claim whatsoever for delaying payment, if any will be entertained.
- l. During Scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/manufactured/fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
