4. Eligibility Bonafide decorators / Contractors having credentials with Electrical Licensee Supervisor of such type of work. Credential & S.T. /I.T./P.T. Clearance certificate to be furnished along with tender.

 - i) The work is of Election emergent nature and the work must be completed within the time as specified in the schedule. Legal action may be taken in case of failure to complete the work. After completion of work certificate of a licensee electrical supervisor is to be produced if necessary.
 - ii) I.T., S.T., & Other charges will be deducted as per Govt. norms.
 - iii) The contractors should quote their offered rate of items in figure as well as in words.

- v) The Successful Tenderer will start the work after receiving the work order on the same day
